Bank Reconciliations Jan 1- April 28 2025

We've seen numerous transactions (in/out) posted to the reserve fund account. The intended purpose is to put money in there for future <u>planned</u> projects (ie meter replacements, testing equipment, pumps, construction projects). Will talk to AVI about this.

Manager's Report

Tank Maintenance and Levels worksheet was reviewed by the Board.

Chuck is actively pursuing accounts receivable starting with "over 31 days late notices" and "over 61 days disconnect notices.

Fill pipe for tank 2 needs to be put on schedule.

Carl Housman wants to scale back on Operator 2 activities. We need to be looking for a replacement. The Drinking Water Bureau website lists contractors available for hire if we get in a pinch.

We need a new Pulsator pump in well house 9

Gary is requesting a fire hydrant pressure gauge. The advantage is the system pressure can be tested without going into member's yards. Purchase was approved; Gary is to get parts for construction. Cost estimate is \$500.

Board members signed Mutual Domestic Reorganization documents (Certificate of Association, Bylaws, Rules and Regulations, and The Open Meetings Resolution).

DWSRF loan terms have not been received.

Met with AVI to discuss Chart of Accounts, budget vs actual tracking.
